 - 4. Provide practical, everyday strategies to assist teachers and staff to provide support and encourage the mental emotional wellbeing of each student.
 - 5. Educate parents to identify, understand and be responsively supportive of their children's mental, social, and emotional needs in school, home and community.
 - 6. Collaborate with community mental health professionals to provide resources and the most widely accepted practices for the development of our students, staff, faculty and parents on the signs and symptoms of most common mental health

issues.

Mr. Gregory Wilkins will teach Science Out-of-Field. Ms. Rachel Goff accepted a teaching position at another school. Ms. Bailey will substitute teach Social Studies Out-of-Field until the position can be filled. The board voted to approve the faculty for the current school year. The following are teaching Out-of-Field:

Ms. Bailey explained school restrooms designations are compliant. Oasis uses SDMC student code of conduct which is compliant. The school Human Resource Manual has been updated establishing disciplinary procedures for employees who violate 553.865(11)(a), F.S. All documentation had been provided to the school district. The board unanimously voted to approve the updated disciplinary procedures.
